- I acknowledge that application for the concealed carry handgun license requires additional fees to the state (Kansas \$150 plus \$12, Missouri up to \$100, and Florida \$117) and proof of firearm training.
- I understand that Kansas and Missouri do not issue concealed carry handgun licenses to non-residents.
- I will abide by all safety rules and follow all range commands given by the instructors, and agree that violations of these rules may result in my dismissal from the class.
- **I do NOT have** a felony conviction, two or more convictions for driving under the influence (DUI), a record of a felony arrest (or I am prepared to produce court records that clearly state the charges were dismissed, not prosecuted or I was found not guilty), a conviction for carrying a concealed firearm, a misdemeanor conviction related to domestic violence (or the conviction was expunged, vacated or set aside), a history of mental illness or substance abuse.
- **I want a concealed handgun license for lawful purposes, including as a means of self-defense.**

VOLUNTARY RELEASE AND FORFEITURE
